VENDORS MUST AGREE TO THE FOLLOWING TERMS:

- 1. Vendors shall only display or sell in the space designated by festival organizers. Vending space may not be shared, sublet, transferred, or otherwise transferred to a third party.
- 2. Vendors are required to set up between 9:00 AM and 11:00 AM, be open for business, display, sale of food and beverages by 11:30 AM and during all of the hours of the Festival from 12:00 PM Noon to 6 pm on the day of the event.

- 3. Vendors shall only sell items listed in and agreed to in this contract. Food items will be reviewed by the festival organizers and you will be notified of approved items.
- 4. Compostable paper cups are preferred, then aluminum cans or glass bottles.
- 5. Food trays, plates, cups, bowls, flatware and any utensil or material provided to the consumer must be made of a compostable or recyclable material.
- 6. We urge vendors to procure products and supplies only in compostable or recyclable packaging. Any materials which cannot be composted or recycled by the festival must be removed from the site by the vendor. This includes any plastic jugs, bottles, tubs or wrapping.
- 7. No ice will be provided.
- 8. No electricity will be provided. If needed, vendors must supply their own generators must be muffled by appropriate means to reduce the sound and placed as directed by festival organizers at a distance of up to 100 feet from the food vendor's booth.
- 9. All electrical and generators must be up to MN state code in order to be used at the festival.
- 10. Vendors must keep their area presentable during the festival and clean their area completely before leaving at the end of the festival. Special attention must be taken to prevent oil stains and/or dumping. This type of damage has a particularly harsh impact on the grounds. Failure to comply will result in a citation.
- 11. FOOD vending vehicles must have plywood or other solid surface under each wheel to prevent turf and tree root damage.
- 12. Vendors are responsible for compliance with all relevant city and state codes and licenses.
- 13. FOOD Vendors must have a seasonal or short-term Minneapolis health **food permit**. The number for this permit must be provided to Freedom Jazz Festival no later than September 5, 2015 to participate in the festival. The city of Minneapolis health inspectors will be on site and will ensure that food dispensing guidelines are followed.
- 14. FOOD Vendors are required to meet all state and local fire codes with regard to propane usage. Failure to pass inspection will cause a vendor to be removed from the event.
- 15. Food vendors must supply proof of insurance showing Minneapolis Park and Recreation Board (MPRB) as additional insured.
- 16. Set up and load in times for the Festival are from 9 am to 11 am on Saturday, September 19, 2015. This is the only time you will be allowed to drive your delivery vehicles into the Festival area. All vehicles, except food trucks, must be out of the park by 11 am. ALL other vehicles must be removed and parked elsewhere. There is NO reserved vendor vehicle parking on-site.
- 17. No one will be allowed to drive into the Festival area during festival hours for restocking or for other needs. A small utility vehicle will be available to assist in transporting supplies from the parking area to your site.

- 18. Load out times for the Festival are from 6:30 pm to 7:30 pm on Saturday, September 19, 2015. No vehicles are allowed into the Festival area until 6:30 pm and attendees have vacated the area.
- 19. No music or other auditory programming is to be played from or in vendor areas during the Festival.
- 20. The Freedom Jazz Festival and MPRB, its organizers, staff, volunteers, assume no responsibility for any financial loss, theft or injury.
- 21. The Freedom Jazz Festival and MPRB assume no liability in the event of any weather condition that may force the cancellation of this event.
- 22. Vendors shall fully indemnify and hold harmless the Freedom Jazz Festival and the Minneapolis Park Board from any actions, suit, claims, payment, costs or damages which may be brought against them arising from participation in the Freedom Jazz Festival.

Upon acceptance, this document is a contract between the exhibitor/vendor and the Freedom Jazz Festival for exhibits, information, merchandise or food vending during the Freedom Jazz Festival. All vendors must abide by this contract. Failure to comply with the terms listed above will result in cancellation of your participation in the Freedom Jazz Festival.
